Acceptance of the Terms of Use

These “Terms of Use” are entered into by and between you and PPN Analytics Limited Liability Company d/b/a TruPacta, a North Carolina limited liability company ("**Company**," "**we**," or "**us**"). The following terms and conditions, (the "**Terms of Use**"), govern your access to and use of www.trupacta.com, including any content, functionality, and services offered on or through www.trupacta.com, or any related subdomain (the "**Website**"), whether as a guest or a registered user.
